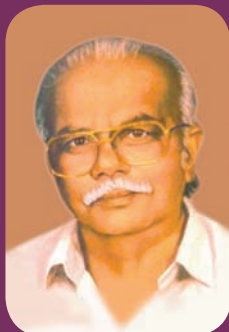

The illustrious and eminent Professor M.C. Jacob took the helm of department in 1969. Under his stewardship, the department was hailed as one of the best Commerce Departments in the erstwhile Kerala University. The milestones of this department often coincided with that of the college itself. It is with the launch of M.Com programme in the Department, in 1981 that the college was elevated to the level of first grade College.

Prof. M.C. Jacob was born on the 23rd of September 1932 as the son of Late Sri. M.M. Chandy and Late Smt. Susamma Chandy. He did his schooling from CMS College High School and completed his graduation from S.D. College, Alappuzha. He obtained his Post Graduation from the Dept. of Commerce, Banaras Hindu University and started his career as a lecturer in the Department of Commerce, Fathima Matha College, Kollam and later on served as a faculty of Dept. of Commerce, S.D College, Alappuzha. Our Department of Commerce had been fortunate to have his eminent and motivating presence from 1967 to 1988.
